Other terms & conditions

Technical Specification

Equipment :Point of care ABG machine

Portable single hand held system for blood gases, lactate, heamatology, chemistries, electrolytes, coagulation and cardiac markers

1. A single portable hand held system weight of the device less than 1 Kg capable of measuring blood gas, lactate and other parameter as mentioned below.
2. It should give the results of GLUCOSE, Na, K, CHLORIDE, IONISED CALCIUM, HCT, PO2 and PCO2 and Cardiac Markers such as Trop I, CKMB, BNP. These tests should be done using not more than 5 catridges. Each test should be provided with calibrators. Price of the cartridge will be taken for evaluation.
3. It should have at least 250 test result storage facility.
4. It should have facility to take print outs.
5. Should have safety certificate from a competent authority CE issued by a notified body registered in the European commission /FDA(US)/STQC CB certificate /STQC S certificate or valid detailed electrical and functional safety test report from ERTL. Copy of the certificate /test report shall be produced along with the technical bid.
6. The system should be operated either through the rechargeable battery or 230Vac with battery backup. In case of rechargeable battery additional one set battery and charger to be provided
7. The cartridge should have atleast 5 month shelf life from the date of supply of hospitals. The bidder shall also replace the cartridges nearing expiry at free of cost on intimation from hospital.
